Re: Proposition 65 Warning Language

This letter is with regard to your inquiry regarding the warning language on ESP International products shipped to California or to the greater United States.

The Safe Drinking Water and Toxic Enforcement Act was adopted in the State of California as a voter initiative (Proposition 65) in November 1986. It provides for restrictions on exposure to and use of certain chemicals which have been determined by the State of California to cause cancer or reproductive toxicity. Proposition 65 requires that businesses operating in California, as well as businesses marketing products in California put warnings notices on any product containing listed chemicals unless the seller has testing data that prove the product meets Proposition 65 exposure level standards.

ESP International has instituted a company-wide policy to label all products that are shipped to, or sold to consumers in California with the required Proposition 65 warning language. There are over nine hundred (900) chemicals on the Proposition 65 list and many ESP products have one or more of the listed chemicals in them. For example, steel, brass, rubber and most machined metals have small amounts of the some of the listed chemicals in them. ESP has determined that conducting the necessary testing to certify exposure levels are below the maximum allowable exposure limits of the Proposition 65 standard on all products would be costly, difficult and time consuming. Therefore, ESP International is placing the warning notices on products to ensure compliance with the California law.
